Order No.G.4762/14/NC dated 26-07-2024

As per reference 1stcited, approval was granted to the Principal. Dr. Moopen's Nursing College, Naseera Nagar, Meppadi, Wayanad to admit 85 students to the BSc Nursing Programme during the academic year 2023-24. The Principal, Dr. Moopen's Nursing College, Naseera Nagar, Meppadi, Wayanad has submitted the application for continuation of affiliation to conduct the BSc Nursing course for the academic year 2024-25.

The Kerala Nurses and Midwives Council in its meeting held on 24-05-2024 and 20-07-2024, vide paper read 2 &3 above, after due deliberations, resolved to grant conditional affiliation to Nursing institutions for the academic year 2024-25 in order to streamline and expedite the admission procedures of various Nursing Programmes in the state.

In the above circumstances, sanction is hereby accorded to grant conditional affiliation to *Principal*, *Dr. Moopen's Nursing College*, *Naseera Nagar*, *Meppadi*, *Wayanad for conducting BSc Nursing programme with an intake of 85* Students for the academic year 2024-25 subject the following conditions.

- 1. Teacher student ratio should be maintained.
- 2. Academic & Administrative matters shall be made only on the basis of the rules and regulations of the University / Government and on the basis of the

- directions issued by the Kerala Nurses and Midwives Council from time to time, failing which the conditional affiliation granted will be withdrawn.
- 3. Affiliation should be obtained from Indian Nursing Council for the course to be conducted during 2024-25.
- 4. Inspection fee for the year 2024-25 should be remitted.
- 5. Admission should only be made to seats sanctioned by INC/KNMC/KUHS.If the number of intake is reduced either by Kerala University of Health Sciences or Indian Nursing Council, the number of seats to which admission can be made should be reduced accordingly.

The management is required to adhere strictly to the guidelines issued by the Government, the Indian Nursing Council and the Kerala Nurses and Midwives Council for conducting the Programme. The Management should obtain affiliation from the Kerala University of Health Sciences, Thrissur. The Management should obtain separate order from the Kerala Nurses and Midwives Council to admit the next batch of students for the academic year 2025-26.
