KUHS - Academic - Nursing - Conditional Provisional Affiliation to Dr. Moopen's Nursing College, Meppadi, Wayanad for the enhancement of B.Sc. Nursing seats from 75 to 85 from the Academic Year 2024-25 - Granted subject to the ratification by the Governing Council - Judgement of Hon'ble High Court in WP(C) no.18252/2024 - Complied - Orders issued.

ORDER

University had invited application for Provisional Affiliation for the enhancement of seats for UG/PG Courses in various streams including Nursing from various affiliated Colleges for the Academic Year 2024-25 vide paper read as (1) above. Accordingly, Principal of Dr. Moopen's Nursing College, Meppadi, Wayanad had submitted application for the enhancement of seats of B.Sc. Nursing Course from 75 to 85 vide.paper read (2) above along with the NOC from government for the same.

- 2. In the meanwhile, the Honourable High court vide judgement read(3) above directed the University to consider and pass orders on the seat enhancement application of the aforesaid college for the next academic year.
- 3. Accordingly University considered the application and rejected the same as the first batch of B.Sc. Nursing course in their college after seat enhancement sanctioned during 2021-22 has not passed out yet.
- 4. Later, the Honorable High court vide judgement read(4) above directed the University to reconsider the application submitted by Dr.Moopen's college, Meppady, Wayanad without insisting on the completion of the batch to which earlier enhancement of seats was granted. It is further directed by the court that, reconsideration of their application has to be done within one month from the date of receipt of judgement.
- 5. Accordingly, University conducted inspection at the College for assessing the facilities in the college for the aforesaid enhancement of seats for the academic year 2024-25 and the Scrutiny Committee after verifying the Inspection report recommended to grant Provisional Affiliation to Dr.Moopen's Nursing College, Meppadi, Wayanad for enhancement of seats in BSc Nursing course from 75 to 85 during the

- 6. The College has submitted the KNMC Approval order for the Academic Year 2024-25 for the aforesaid enhancement but the INC Suitability for the same has not submitted.
- 7. The whole matter was placed before the Sub Committee of the Governing Council and the Sub Committee vide paper read (5) above, recommended to grant Conditional Provisional Affiliation for the enhancement of B.Sc. Nursing seats at Dr.Moopen's Nursing College, Meppadi, Wayanad from 75 to 85 for the academic year 2024-25 on the condition that;
- The institution shall have to obtain INC approval for the aforesaid enhancement of seats in B.Sc. Nursing course for the academic year 2024-25.
- If the sanctioned intake is reduced by INC, the same shall be taken into account for admission of students.
- 8. In the circumstances, considering the urgency of admission process to nursing course and as per the statute 2 (5) ix (16) of the first statute amended on the matter of affiliation, sanction is hereby accorded to grant Conditional Provisional Affiliation to Dr.Moopen's Nursing College, Meppadi, Wayanad for the enhancement of B.Sc. Nursing seats from 75 to 85 during the academic year 2024-25 in anticipation of the INC suitability for the Academic Year 2024 25 and subject to ratification of Governing Council.
- 9. The Affiliation granted now is subject to following conditions:• The college should submit approval from INC for the enhanced seats for the academic year 2024-25. If the sanctioned intake is reduced by INC, the same shall prevail.
- · The college shall also produce an undertaking to the university within seven days from the date of receipt of this order that the loss suffered by the students admitted to the college shall be compensated by the College as determined by the university, in the event of this conditional affiliation not made absolute due to the failure bv the college in fulfilling the conditions stipulated • If the conditions noted above are not satisfied, the Conditional Provisional Affiliation now granted shall cease automatically as stipulated in the affiliation statute 2(5) ix (16).
- 10. The colleges shall strictly adhere to the general conditions detailed below:i. Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Government of Kerala and on the basis of the directions issued by the University from time to time, failing which the Affiliation granted will be cancelled.
- ii. In the light of the direction of the Supreme Court of India in Writ Petition (c) 56/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of Affiliation of the College will be initiated.
- iii. Affiliation granted is strictly provisional and is only for the academic year 2024-25. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex body concerned.
- iv. The college shall remit annual administration fee fixed for respective UG / PG courses for the academic year 2024-25.
- v. Admission to the next academic year shall be made only after obtaining prior permissions from the University.
- 11. The Judgement vide paper read (4) above is thus complied with.
