## **ORDER**

The University had invited applications for Continuation of Provisional Affiliation for the Academic Year 2024-25 from the colleges affiliated to the University, vide paper read (1) above. Accordingly, the Principals of colleges mentioned in para (3) had submitted the applications for Continuation of Provisional Affiliation to conduct the courses with intake mentioned against each.

- 2. The University conducted inspection at these institutions in order to verify the facilities available for granting Continuation of Provisional Affiliation for the academic year 2024-25. The scrutiny committee has pointed out certain deficiencies after verifying the inspection reports and the same was intimated to the Principals of respective institutions for rectification.
- 3. Subsequently, the colleges submitted rectification reports and verifying the same, the scrutiny committee recommends to grant Continuation of Provisional Affiliation to colleges mentioned in table below for conducting the courses with intakes mentioned against each during the academic year 2024- 25.

- 4. The colleges have not submitted INC Renewal suitability & KNMC Approval for the Academic year 2024-25.
- 5. The whole matter was placed before the Governing council and the Governing council, vide paper read (2) above, resolved to grant Continuation of Provisional affiliation to the colleges mentioned in table above for the conduct of courses with seats mentioned against each for the Academic year 2024-25, in anticipation of Approval from INC & KNMC.
- 6. In these circumstances, sanction is hereby accorded to implement the Decision No.79.27 of the Governing Council granting Continuation of Provisional Affiliation to 5 Nursing colleges mentioned in table above for the conduct of courses with intake mentioned against each for the academic year 2024-25, in anticipation of approvals from INC & KNMC for the academic year 2024-25.
- 7. The colleges shall strictly adhere to the general conditions detailed below:-
- i) Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Government of Kerala and on the basis of the directions issued by the University from time to time, failing which the Affiliation granted will be cancelled.
- ii) In the light of the direction of the Supreme Court of India in Writ Petition (c) 56/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of Affiliation of the College will be initiated.
- iii) Affiliation granted is strictly provisional and is only for the Academic Year 2024-25. The college has to apply for Continuation of Provisional Affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex body concerned.
- iv) The Colleges shall remit Annual Administration Fee fixed for UG/PG courses for the Academic Year 2024-25.
- v) Admission to the next academic year shall be made only after obtaining prior permissions from the University.
- vi) The colleges should submit approval order from INC and KNMC for the year 2024- 25.
